Immunization Requirements

It is the responsibility of the Owner to provide proof of vaccination for each pet that will be boarding or attend day care at Pat the Dog, herein after referred to as PTD. Pets whose shots are not up-to-date will not be allowed on the PTD premises.

Minimum vaccination required for guests are:

DOGS: Current Rabies, Bordetella & DHLPP (distemper & parvo)

OWNER UNDERSTANDS THAT EVEN IF OWNER'S DOG(S) IS VACCINATED AGAINST CANINE COUGH (BORDETELLA), THERE IS A CHANCE THAT THE OWNER'S DOG CAN STILL CONTRACT CANINE COUGH. I AGREE THAT I WILL NOT HOLD PTD RESPONSIBLE IF OWNER'S DOG(S) CONTRACT CANINE COUGH.

BOARDING, GROOMING & DAYCARE CONDITIONS AND AGREEMENT

1) Minimum vaccination requirements for pets are:

DOGS: Current Rabies, Bordetella & DHLPP (distemper & parvo)

- 2) ALL pets will be checked for fleas and ticks upon arrival and if it is established that they carry fleas/ticks, they will be treated with flea spray and/or tick bath at the owner's expense. The fee will be \$ 15.00 for Small/Medium guests and \$ 25.00 for Large/XLarge guests.
- 3) Pets sharing the same room/cage must be able to eat together at the same time without supervision. There may be additional charges if you have to separate for feeding.
- 4) Pets must be dog and people friendly. Any dog that bites or is not manageable may be refused. If your pet is to bite or injure one of our kennel techs or another pet while staying at Pat the Dog, you as the owner will be held liable for any cost incurred by your pet(s) actions.
- 5) Collars and/or leads are not necessary unless someone else is picking up your pet.

 These should be taken home at the start of the boarding period, since they could get lost.
- 6) Pat the Dog recommends that pet owners bring their own food for all guests. If Pat the Dog has to provide food for the pet, a \$ 2.00/day charge for each pet will be added to the boarding rate.
- 7) Food should be placed in zip-lock bags, or 8 lbs bags. Small Tupperware containers may also be used. Large ones that will not fit in bins should not be used. Large bags (20lbs or larger) will be turned away. First time we will repackage food into provided zip-lock bags for free, the second time the owner will be charged \$1.00 per bag for the repackaging.
- 8) All bedding must be able to fit in a standard washing machine. List all belongings you bring with your pet and make sure all belongings including toys carry your pet's name
- 9) In the case the pet(s) become ill or appears to need the attention of a veterinarian, the kennel's operator will first call the pet's owner at the numbers listed. Following that, our on call vet will be called. All charges from such a veterinarian are to be at the expense of the pet(s) owner. In cases of emergency at the sole discretion of PTD, the vet may be called first.
- 10). If any pet(s) are not picked up or arrangements made for the settlement of the bill within ten(10) days of the specified departure date, Pat the Dog may take actions to place the pet(s) in a new home or shelter.

- 11) In the event that an injury or illness is discovered after the pet has left the premises after either boarding, grooming, day care or training, PTD must be contacted within 3 days and prior to any veterinary treatment.
- 12) Pet owner is responsible for any and all collections, court and/or attorney costs and fees on unpaid bills.
- 13) You, as the owner of the pet, are responsible for any damage done by your pet to the inside or outside of PTD property.

Boarding Agreement:

The described pet(s) will be kept in a clean and sanitary condition with ample food and water. While every precaution will be taken to prevent disease, injury, escape, fire, death, sickness, etc., animals that are placed in the care of Pat The Dog are placed at the sole risk of the owner of said pet(s). The owner further agrees to be solely responsible for any and all actions of their pet(s) while he/she is boarded/groomed at Pat the Dog. Owner agrees that he/she understands that this is a legally binding contract. If not understood, seek the services of an attorney. In signing this contract and leaving his/her pet(s) with Pat the Dog, the owner certifies to the accuracy of all information given about said pet(s) in this contract.
